General Trust Fund Payout

The General Trust Fund (GTF) payout for a given year is 4% of the difference between the market value of the GTF and the market value of any funds not yet eligible for payout or controlled by donor constraints on June 30 of the prior year.

General Trust Fund Total NCFF/FCNC Payout (only a portion of the total GTF payout)

General Trust Fund Payout

2025 General Trust Fund payout amounts have been provided by category to NCFF, FCNC, QLC and "Cemeteries" for their budgeting processes.

General Trust Fund Investment Guidance

In the latter half of 2021, with the extraordinary growth and volatility in stock market values, the Trustees of Trust Funds requested the latitude to allow the percentage of equities to grow to 85% of the General Trust Fund, rather than constantly rebalancing to limit equities to 75% of the Fund. This was approved by the NCYM, Inc. Board, with the understanding that, as market conditions return to more typical patterns, equities will again comprise approximately 75% of the General Trust Fund.

General Trust Fund

Due to the changes anticipated in the composition of the Trustees of Trust Funds over the next few years, the Trustees have largely completed a migration from Trustee-selected equities and bonds to TD Ameritrade/Schwab managed funds. The ratio of equities to bonds is being normalized to approximately 75% - 25% in the process.
